**C.I.Y.C. By-Law
Article V. Membership
Section T**

An adult person must present their written application for membership, endorsed by two (2) members in good standing who have been members for at least six (6) months. If the application for membership is submitted prior to October 1, prorated dues for the current year shall apply, as well as any initiation fee. If application for membership is submitted after October 1, payment of any initiation fee shall be required, however, no proration of annual membership dues shall apply. Instead, payment of a full year of membership dues is required and shall be credited towards next years' annual dues payment. The application shall be submitted to the BOD for their recommendations
Acceptance of the application and fees by the BOD shall signify that a probationary period not to exceed six (6) months has commenced.
